### Review and Approval of Vision Insurance Coverage for Staff

Jo Ann presented information about a Delta Dental Vision Plan for staff. She said that this would be an added benefit for employees. Projected costs for the plan were discussed and Annette assured the committee that funding was available for the added benefit.
