Business Meeting

Approval of Employee Health/Life Insurance Coverage

Jo Ann informed members that the Employee Health (and Life) Insurance coverage with United Health Care will renew on January 1, 2023. She said that the current plan that we have with UHC is no longer available, but they did quote us a plan that is similar. Jo Ann outlined the following change in benefits:

Increase Non-Network Deductible from \$4,500/\$9,000 to \$5,000/\$10,000 Increase of out of pocket from \$7,000/\$14,000 to \$7,750/\$15,500 Decreased Office Co-pays from \$35/\$70 to \$15/\$60

Decreased Coinsurance for Non-Network from 60% to 50%

Overall, Jo Ann told members that we received a 1.1% increase on our health benefit. She said that she talked with our agent, Tom Payton and he did not formally quote this year because of the 1.1% increase. Jo Ann told members that most of Tom's groups with Blue Cross/Blue Shield went up 8%. She said that one thing of interest should be that the Office Co-Pays went down from \$35.00 to \$15.00 that shows the staff is taking advantage of the benefits. Although we received a 1.1% increase, it is manageable and affordable. Jo Ann recommended that the plan as presented offered by United Health Care be renewed effective January 1, 2023. Jamey Sulser motioned to approve the United Health Care plan as presented effective January 1, 2023. Motion was seconded by Jim Duffy. Roll Call vote was taken.
