## Apprenticeship Expansion Grant

Carrie informed members that a Notice of Funding Opportunity (NOFO) was released for an Apprenticeship Expansion Grant. She told members that she submitted an intent to apply for funds in the amount of \$175,000. She told members that a large amount of this funding would go to working with Jo Carroll Energy and Wolfline Construction to stand up 2 apprenticeship programs for broadband technicians. This will also allow, Carrie said, for the purchase of 2 virtual reality goggles and the development of 10 career exploration experiences for the 2 career centers (CTE Academy and WACC) to create a career pathway into the apprenticeship programs. Of the \$175,000, Carrie said that \$70,000 of it is budgeted for staff costs to help this this program started. Carrie said that we can start using the funding in July although we have not received confirmation that the intent to apply for funds has been received. Carrie pointed out that Dianna Schuler has been working with Jo Carroll Energy for some time on this project and feels that it will be a good fit. Chris Flikkema motioned to authorize Carrie to proceed with the grant application if intent is accepted by DCEO. Motion was seconded by Wayne Reising. Roll Call vote was taken.
