Executive Director Report

Carrie informed members that President Donald Trump signed Executive Orders aimed at ending cashless bail policies. She said that these orders could threaten federal funding to States that have eliminated cash bail. Carrie told members that she has a meeting scheduled for September 8 to discuss this matter, but she wanted to give members a heads up in case they heard it through the news media. Carrie shared with members that in 2022, the State of Illinois received \$42.6 billion dollars in federal dollars, which is 36.3% of their general revenue.

Carrie referred members to the Fourth Quarter Performance Report (Page 13) and the Year-to-Date Manager's Report (Page 14) that were included with the meeting materials. She said that the Quarterly Performance Reports are usually included with the meeting materials, but she included the Year-to-Date Manager's Report as it reflects that BEST, Inc. has either exceeded or met each of the Performance

Measures. Carrie said that staff will be negotiating Performance Measures for PY 25/PY 26 relatively soon. Carrie also pointed out that with the Statistical Adjustment Model our performance is good.

Referring to the NCI Works Customer Satisfaction Survey (Page 17), Carrie explained that this is a new survey that came out of the One Stop Partner Committee to assess the services being offered through the One Stop System. She said that starting on April 1 each Partner was given a poster and palm cards that contained a QR Code. Staff from each of the One Stop Partners, Carrie said, are asked to give this information to their customers asking them to log on to the survey and complete it. Carrie reviewed some of the results of the survey that were included with the meeting materials.

Finance Director Report

Jessica provided the Finance Director Report. She told members that BEST, Inc. received the PY 25 WIOA Grant last week and those funds are available to us. All other grants have not been executed yet.

Gary Camarano motioned to approve the Fiscal Reports ending June 2025. Motion was seconded by Wayne Reising. Roll Call vote was taken.
